

#### Vertical structure


- Focus on individual issues related to the circular

# The european strategy on circular economy

#### A New Circular Economy Action Plan

- Cojectives
   Make sustainable products the norm in the EU
   Empower consumers and public buyers
   Focus on the sectors that use most resources and where the potential for circularity is high such as: electronics and ICT, batteries and vehicles, packaging, plastics, textiles, construction and buildings, food, water and nutrients
   Ensure less waste
   Make circularity work for people, regions and cities
   Lead global efforts on circular economy

#### Proposed measures

European Commission adopted package of measures proposed in the circular economy action plan:

- Sustainable products initiative, including the proposal for the ecodesign for sustainable products regulation – (COM (2022)142) where 14 eco-design requirements were included that evaluate all phases of the product life cycle
- EU strategy for sustainable and circular textiles
- Proposal for a revised construction products regulation
- Proposal for empowering consumers in the green transition
  Proposal for a directive on green claims
  Proposal on common rules promoting the repair of goods
